On the 50th anniversary of Title IX of the Education Amendments of 1972, the U.S. Department of Education released proposed amendments to the Title IX regulations (again). The earliest the Biden proposed amendments will become effective would be in time for the 2023–2024 school year, and the proposed rules may undergo some changes in response to comments. However, because the final rules that become effective likely will be similar to those proposed, it makes sense to familiarize yourself with them now. We will provide a side-by-side comparison of the current and the proposed Title IX rules, and discuss the changes that will need to be implemented at the K-12 school level.
